**Re: Notice of Data Event**

To Whom It May Concern:

We represent Accounting & Advisory Services, P.A. (“Accounting & Advisory Services”) located at 8001 College Blvd., Suite 150, Overland Park, KS 66210, and are writing to notify your office of an incident that may affect the security of certain personal information relating to one (1) Virginia resident. By providing this notice, Accounting & Advisory Services does not waive any rights or defenses regarding the applicability of Virginia law, the applicability of the Virginia data event notification statute, or personal jurisdiction.

**Nature of the Data Event**

On or about September 17, 2024, Accounting & Advisory Services became aware of suspicious activity in certain systems within its network. As a result, Accounting & Advisory Services launched an investigation into nature and scope of the activity. Through this investigation, Accounting & Advisory Services concluded that a subset of files and folders on its network were subject to unauthorized access or acquisition between September 11 and 12, 2024. Following this discovery, Accounting & Advisory Services commenced a thorough review of the potentially impacted files and folders to determine the information potentially at risk and the individuals to whom it relates, which concluded on January 24, 2025.

The information that could have been impacted includes name and Social Security number.

### **Notice to Virginia Resident**

On or about May 14, 2025, Accounting & Advisory Services provided written notice of this incident to one (1) Virginia resident. Written notice is being provided in substantially the same form as the letter attached here as *Exhibit A*.

### **Other Steps Taken and To Be Taken**

Upon learning of the activity, Accounting & Advisory Services immediately took steps to ensure the security of its systems, investigate the event, and identify potentially affected individuals. Accounting & Advisory Services is also working to implement additional safeguards and training to its employees. Accounting & Advisory Services is providing access to credit monitoring services for twelve (12) months, through Experian, to individuals whose personal information was potentially affected by this incident, at no cost to these individuals.

Additionally, Accounting & Advisory Services is providing impacted individuals with guidance on how to better protect against identity theft and fraud. Accounting & Advisory Services is providing individuals with information on how to place a fraud alert and security freeze on one's credit file, the contact details for the national consumer reporting agencies, information on how to obtain a free credit report, a reminder to remain vigilant for incidents of fraud and identity theft by reviewing account statements and monitoring free credit reports, and encouragement to contact the Federal Trade Commission, their state Attorney General, and law enforcement to report attempted or actual identity theft and fraud.

Accounting & Advisory Services is providing written notice of this incident to relevant state and federal regulators, as necessary.

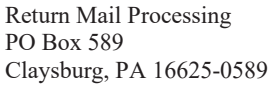

## **Monitor Your Accounts**

Under U.S. law, a consumer is entitled to one free credit report annually from each of the three major credit reporting bureaus, Equifax, Experian, and TransUnion. To order a free credit report, visit [www.annualcreditreport.com](http://www.annualcreditreport.com) or call, toll-free, 1-877-322-8228. Consumers may also directly contact the three major credit reporting bureaus listed below to request a free copy of their credit report.

Consumers have the right to place an initial or extended “fraud alert” on a credit file at no cost. An initial fraud alert is a 1-year alert that is placed on a consumer’s credit file. Upon seeing a fraud alert display on a consumer’s credit file, a business is required to take steps to verify the consumer’s identity before extending new credit. If consumers are the victim of identity theft, they are entitled to an extended fraud alert, which is a fraud alert lasting seven years. Should consumers wish to place a fraud alert, please contact any of the three major credit reporting bureaus listed below.

As an alternative to a fraud alert, consumers have the right to place a “credit freeze” on a credit report, which will prohibit a credit bureau from releasing information in the credit report without the consumer’s express authorization. The credit freeze is designed to prevent credit, loans, and services from being approved in a consumer’s name without consent. However, consumers should be aware that using a credit freeze to take control over who gets access to the personal and financial information in their credit report may delay, interfere with, or prohibit the timely approval of any subsequent request or application they make regarding a new loan, credit, mortgage, or any other account involving the extension of credit. Pursuant to federal law, consumers cannot be charged to place or lift a credit freeze on their credit report. To request a credit freeze, individuals may need to provide some or all of the following information:

1. Full name (including middle initial as well as Jr., Sr., II, III, etc.);
2. Social Security number;
3. Date of birth;
4. Addresses for the prior two to five years;
5. Proof of current address, such as a current utility bill or telephone bill;
6. A legible photocopy of a government-issued identification card (state driver’s license or ID card, etc.); and
7. A copy of either the police report, investigative report, or complaint to a law enforcement agency concerning identity theft if they are a victim of identity theft.

Consumers may further educate themselves regarding identity theft, fraud alerts, credit freezes, and the steps they can take to protect their personal information by contacting the consumer reporting bureaus, the Federal Trade Commission, or their state Attorney General.
